In Luxembourg, there are various subsidies for the installation of photovoltaic solar panels. PRIME House: this scheme makes it possible for you to benefit from a subsidy equivalent to 20% of the cost of installing photovoltaic panels, and these must be rated at lower than 30 kW. This subsidy may reach EUR 500 per kWp.
