This is because a solar panel system usually weighs about 20kg per square metre, which the great majority of roofs can hold. However, flat roofs may not always be strong enough for solar panels. Drilling into a flat roof can cause leaks, so an installer will usually ballast the panels instead - but these will add around 80kg per panel.

Under the SEG, everyone who owns a solar panel system with at least a 5MW capacity is entitled. Your 5kW solar system with battery in the UK would be eligible for the Smart Export Guarantee. Additionally, the house must have a smart meter so the exports can be measured. Solar storage is also included in the new scheme.

Owing to the extremely technical nature of the solar panel installation process, it's highly advised that you use trained professionals to add a solar network to your home. While you might be able to buy the basic resources for the build yourself ahead of time, you'll need to turn to a qualified installer to carry out the job itself.
