

## Complaint on Photovoltaic Panel Quality Dispute

How do I make a complaint about a solar installation?

When making a complaint it is useful to have the following information: The date of installation may be present on installation paperwork and may also be on the energy efficiency measure, such as the loft installation, the boiler, or the Solar PV inverter. Please contact the ECO team (ECO.SAR@ofgem.gov.uk) to raise a Subject Access Request.

When can I complain about my energy supplier?

You must complain to the ombudsman within 12 months fyour supplier telling you their decision. If your supplier hasn't given you a decision you might have longer than 12 months, but it's still worth complaining as soon as you can. You can register your complaint to the energy ombudsman:
