However, IRENA Energy Transformation Scenario forecasts that these targets should be at 61% and 9000 GWh to achieve net zero ...

Super-capacitor energy storage, battery energy storage, and flywheel energy storage have the advantages of strong climbing ability, flexible power output, fast response speed, and strong plasticity [7]. More development is needed for electromechanical storage coming from batteries and flywheels [8].
