Another important question to consider is, "What size solar panels do I need?". For this, you will need to factor in the size of your roof or the area of the property where you want to install your panels. The average solar panel system produces 8kWh to 11kWh daily and requires a minimum of 14m 2 of roof space.

From 1 February 2024, you won"t pay any VAT on batteries for solar panels (previously you had to pay 20% VAT, unless you bought it as part of a solar panel system). So now you can install a standalone energy storage battery or add one to your existing solar PV system, and you"ll pay 0% VAT. From 1 April 2027, this is set to increase to 20% VAT.

How much do solar panel repairs cost? To limit having to pay for any repairs, you need to get your solar panels serviced at least once every 5-10 years. A solar panel service will set you back around £100, but it will also prevent any possible future issues for your solar panel system, and hopefully, lead to 30 long years of solar-soaking panels.

The cost of a typical solar storage battery that can store about 5.1kWh of power can add around EUR3,600 to EUR4,000 to the cost of a PV solar panel installation. While solar storage batteries can be a significant upfront cost, ...
