Users can link their bank cards, receive and transfer money, pay bills, and make purchases both in-store and online. Download WeChat from the App Store or Google Play.

#### How do I deduct money from my WeChat wallet?

1. Go to Wallet 2. Click on the top right corner 3. Click on Manage Payment 4. You will see a button called "Auto-Deduct". Click once It will show the apps or third party apps that links with your Wechat Wallet and allows the app to deduct your money automatically without verifying password or fingerprint identification.

#### How do I pay electricity using Alipay & WeChat wallet?

To pay electricity, link your utilities account to the payment platform, then specify the amount of money you want to recharge. To complete the transaction, enter your six-digit Alipay or WeChat Wallet payment PIN.

That is, while taxpayers in every state and DC claim the SALT deduction, taxpayers in states with a disproportionate share of high-income taxpayers and relatively high state and local individual income taxes are more likely to claim the deduction (figure 1).
