How can a small business save money on energy costs?

Some local governmentsprovide tax incentives and rebates to small businesses if you buy energy-saving equipment. The U.S. Small Business Administration estimates that heating, ventilation and air conditioning systems account for about 40% of the electricity used in commercial buildings.

How much energy does a small business use?

Many small businesses reside in commercial buildings smaller than 50,000 ft 2, which consume 44% of U.S. commercial building energy use (nearly 3 quadrillion Btu annually). There are three key reasons small business owners should improve the energy efficiency of a building:
