The developer said last week (23 June) that it has commenced commercial operations, including bidding into power markets, for the battery energy storage system (BESS) projects. Each site comprises a 2MW, 4-hour duration BESS (8MWh).

Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) has invited proposals to install standalone battery energy storage systems (BESS) with a total capacity of 600 MWh. Projects will be selected via e-bidding and e-reverse auction, with a minimum bid size of 100 MWh. The BESS will be built, owned, and operated by developers and charged by MSEDCL for daily use.

Since Chile passed a major energy storage bill, gigawatts of energy storage co-located with solar PV are being built in the country. Earlier this year the country opened a public land bidding auction seeking 13GWh of standalone energy storage projects across four regions - Arica and Parinacota, Tarapaca, Antofagasta and Atacama.

# Energy storage battery project bidding

The 250MW/500MWh project is worth IR13.4 billion (US\$160.4 million), Gensol said in a 12 June announcement, noting that GUVNL could take a "greenshoe" option to expand the project to 500MW/1,000MWh which would generate IR26.8 billion for the company over the 12-year term of a battery energy storage purchase agreement (BESPA).

Concerning utility-scale energy storage, there is a pressing need for its deployment. Additionally, the crucial role played by grid-side energy storage installations, dominated by standalone and shared energy storage, is expected to be a significant driver for the growth of utility-scale storage. Projections for New Installations of ESS in 2024

Since 2020, the Minister of Mineral Resources and Energy has determined that 28GW of new generation capacity can be procured through the REIPPP programme, and four bid windows have since been released, including the RMIPPPP, and REIPPP Bid Windows 5 and 6, and the first Battery Energy Storage IPP Procurement bid window (BESIPPPP Bid Window 1).

The 25MW/50MWh battery is a Tesla Powerpack system. It's jointly owned by Edify Energy and Wirsol Energy and operated by Energy Australia. This battery is used to smooth the output of the Gannawarra solar farm, allowing the combined solar and battery system to provide power when there is no sun.

Maharashtra State Electricity Distribution Company has issued a request for selection to set up pilot projects of 300 MW/ 600 MWh standalone battery energy storage systems in Maharashtra under tariff-based global competitive bidding. The last date for submission of bids is August 26, 2024. Bidders must pay a document fee of INR29,500 (~\$351.52).

Other markets in the region are set to kickstart growth with more targeted support for storage through auctions, or grants for specific projects. There are 3 types of support that we see being offered or planned: Storage auctions: Hungary is set to have its first storage auction for around 900MWh of new electricity storage by the end of 2026.

US grid-scale battery storage developer Key Capture Energy has become the latest player in the market to launch its own energy bidding software tool for wholesale market trades.
