Energy storage devices are critical in applications such as UPS and data centers because this region is prone to frequent power outages.

Are battery energy storage systems the leading technology for new projects?

Although several competing UES technologies with differing characteristics are matched for certain applications, battery energy storage systems (ESSs) are emerging as the leading technology globally for new projects. Thus, this Leaderboard is focused on battery technologies and the companies responsible for their integration.

#### Which countries are deploying a new storage system in 2025?

The clean power ambitions of state governments and utilities propel storage deployment in the U.S. In China,the ambitious installation target of 30 gigawatts of cumulative build by 2025 and stricter renewable integration rules boost expected storage installations. Other top markets include India,Australia,Germany,the U.K. and Japan.

Why are energy storage technologies becoming more popular?

Due to the low recyclability and rechargeability of lithium batteries, alternate forms of batteries such as redox and solid-state are also rising. Additionally, innovative thermal and hydrogen storage technologies reduce the carbon footprint of the energy storage industry.
