Is energy storage a profitable business model?

Although academic analysis finds that business models for energy storage are largely unprofitable, annual deployment of storage capacity is globally on the rise (IEA,2020). One reason may be generous subsidy support and non-financial drivers like a first-mover advantage (Wood Mackenzie, 2019).

Can a market product incentivise the deployment of energy storage systems?

The innovative market product presented in the previous section, and already implemented by some system operators, can incentivise the deployment of flexible resources such as energy storage systems, as it will suppose an additional revenue stream that can make these projects economically feasible.

How can energy storage be profitable?

Where a profitable application of energy storage requires saving of costs or deferral of investments, direct mechanisms, such as subsidies and rebates, will be effective. For applications dependent on price arbitrage, the existence and access to variable market prices are essential.

Does project finance apply to energy storage projects?

The general principles of project finance that apply to the financing of solar and wind projects also apply to energy storage projects. Since the majority of solar projects currently under construction include a storage system, lenders in the project finance markets are willing to finance the construction and cashflows of an energy storage project.

Which energy technologies are the most profitable?

The most examined technologies are again CAES (27 profitability estimates), batteries (25), and pumped hydro (10). Recent deployments of storage capacity confirm the trend for improved investment conditions (U.S. Department of Energy, 2020).

How is energy storage industry segmented?

The report covers US Energy Storage Companies and it is segmented by Technology (Batteries and Other Energy Storage System Technologies), Phase (Single Phase and Three Phase), and End-User (Residential and Commercial & Industrial).

Why securing project finance for energy storage projects is challenging. It has traditionally been difficult to secure project finance for energy storage for two key reasons. Firstly, the nascent nature of energy storage
