How can NREL develop transformative energy storage solutions?

To develop transformative energy storage solutions, system-level needs must drive basic science and research. Learn more about our energy storage research projects. NREL's energy storage research is funded by the U.S. Department of Energy and industry partnerships.

Why is energy storage important?

Energy storage is a potential substitute for, or complement to, almost every aspect of a power system, including generation, transmission, and demand flexibility. Storage should be co-optimized with clean generation, transmission systems, and strategies to reward consumers for making their electricity use more flexible.

How has energy storage been developed?

Energy storage first passed through a technical verification phase during the 12th Five-year Plan period, followed by a second phase of project demonstrations and promotion during the 13th Five-year Plan period. These phases have laid a solid foundation for the development of technologies and applications for large-scale development.

What was the growth rate of energy storage projects in 2020?

In 2020, the year-on-year growth rate of energy storage projects was 136%, and electrochemical energy storage system costs reached a new milestone of 1500 RMB/kWh.

What is the leasing model for energy storage projects?

Another such model is the leasing model for front-of-the-meter energy storage projects adopted by Hunan province in 2018, and the subsequent 2020 upgraded version of the leasing model which applied to energy storage paired with renewable generation and designed to split investment risks between each entity.

**Solutions Research & Development.** Storage technologies are becoming more efficient and economically viable. One study found that the economic value of energy storage in the U.S. is \$228B over a 10 year period. 27 Lithium-ion batteries are one of the fastest-growing energy storage technologies 30 due to their high energy density, high power, near 100% efficiency, ...

Relying on the advanced non-supplementary fired adiabatic compressed air energy storage technology, the project has applied for more than 100 patents, and established a technical system with completely independent intellectual property rights; the team developed core equipment including high-load centrifugal compressors,
