How much energy storage will Europe have in 2022?

Many European energy-storage markets are growing strongly, with 2.8 GW(3.3 GWh) of utility-scale energy storage newly deployed in 2022, giving an estimated total of more than 9 GWh. Looking forward, the International Energy Agency (IEA) expects global installed storage capacity to expand by 56% in the next 5 years to reach over 270 GW by 2026.

When will European energy storage start?

In the European energy storage market, Eastern European countries started later than their Western European counterparts. In September 2022, Romania announced a goal to deploy 480 MWh of battery energy storage by 2025.

How big will energy storage be in the EU in 2026?

Looking forward, the International Energy Agency (IEA) expects global installed storage capacity to expand by 56% in the next 5 years to reach over 270 GW by 2026. Different studies have analysed the likely future paths for the deployment of energy storage in the EU.

What are EU energy storage initiatives?

European Union EU energy storage initiatives are key for energy security and the transition toward a carbon-neutral economy, improving energy efficiency, and integrating more renewable energy sources into electricity systems.

What is the European Commission doing about energy storage?

In 2020,the European Commission published a study on energy storage,which summarized some previous studies and reports,explored current and potential energy storage markets in Europe,and set out policy and regulatory recommendations for energy storage.

What is the biggest energy storage project in Sweden?

Neoen and Nidec announced construction of a 9 MW/93.9 MWh BESS- the largest BESS project in both Sweden and all of Northern Europe. It is expected to enter operation in the first half of 2025. BESS remained the mainstay of energy storage projects over the quarter, with a small number of PHS projects promoted.
