Both agreements are significant for each market. For instance, India continues to add to its growing PHES development pipeline, with the Central Electricity Authority of India (CEA) having fast-tracked a further 2,500MW of PHES on Sunday (22 September), adding to the 2,600MW announced in August.. This is another significant PHES development for Spain.

The Ministry of Power has issued guidelines to govern and promote the development of pumped storage projects (PSP) throughout the country. These guidelines clarify the methods for project site allocation through competitive bidding and rule out any upfront premium for project allocation in order to make it financially viable.

The Indian government has issued the final guidelines to encourage the development of non-polluting and eco-friendly pumped storage projects (PSPs). The state government may award developers project sites through a competitive bidding process, tariff-based competition, and on a nomination basis to CPSUs and state PSUs. Construction work ...

The transaction concerns an 85-MW battery energy storage system (BESS) which will be coupled with a 75-MW/530-MWh underground pumped hydro storage (UPHS), which will use the existing mine structure.
