The project will also pave the way for the country to reduce its greenhouse gas emissions by 2.5 times its 2025 target. The financing package for the project, worth over US\$200 million, through loans and grants from six institutions, marks the first large-scale infrastructure project for Solomon Islands to be developed as a public-private ...
