

# How to enter overseas energy storage projects

How big are energy storage projects?

By the end of 2019, energy storage projects with a cumulative size of more than 200MWh had been put into operation in applications such as peak shaving and frequency regulation, renewable energy integration, generation-side thermal storage combined frequency regulation, and overseas energy storage markets.

Should energy storage projects have multiple construction contracts?

Construction risks: It is common practice to see multiple equipment supply, construction, and installation contracts rather than one turnkey engineering, procurement, and construction (EPC) contract for energy storage projects.

Construction of the Rochi Energy Storage Project in Angren District of Uzbekistan is now underway. Invested and built by China Gezhouba Group Overseas Investment Co., Ltd., a subsidiary of China Energy Engineering Group Co., Ltd (Energy China), the project is the largest electrochemical energy storage project invested by a Chinese enterprise overseas.

Comparatively speaking, BYD's energy storage business has had a much more muted presence domestically than overseas. China energy storage installed demand continues to grow. According to data, from January to June 2024, domestic energy storage system project bidding capacity is 41.1GWh. By comparison, BYD began exploring the energy storage sector as early as 2008. While it initially focused on the Chinese market, the company has gradually shifted its energy storage business emphasis to overseas markets, particularly Britain, where BYD's 325 MW energy storage capacity played a significant role in the sector.
