Does China Huaneng have a wind farm?

China Huaneng has longstanding expertise in developing wind farms, and the scale of the Puyang project will surpass a previous cooperation between GE and China Huaneng - the 151 MW Huaneng Dali Longquan wind project in Yunnan - which uses GE's 2.75-120 turbine, the largest onshore wind turbines in China at the time.

Who is China Huaneng Group?

In 2002, China Huaneng Group became part of one of China's earliest carbon emissions trading programs, the " 4 + 3 + 1 " program. In 2011 China Huaneng Group floated its wind power subsidiary Huaneng Renewables on the Stock Exchange of Hong Kong.

Where is Huaneng Power International listed?
