The battery energy storage systems industry has witnessed a higher inflow of investments in the last few years and is expected to continue this trend in the future.

Europe and China are leading the installation of new pumped storage capacity - fuelled by the motion of water. Batteries are now being built at grid-scale in countries including the US, Australia and Germany. Thermal energy storage is predicted to triple in size by 2030. Mechanical energy storage harnesses motion or gravity to store electricity.

Grid-scale storage plays an important role in the Net Zero Emissions by 2050 Scenario, providing important system services that range from short-term balancing and operating reserves, ancillary services for grid stability and deferment of investment in new transmission and distribution lines, to long-term energy storage and restoring grid ...

The energy storage market size in United States exceeded USD 68.6 billion in 2023 and is projected to register 15.5% CAGR from 2024 to 2032, impelled by the increasing demand for refurbishment and modernization of the existing grid network.

Battery overproduction and overcapacity will shape market dynamics of the energy storage sector in 2024, pressuring prices and providing headwinds for stationary energy storage deployments. This report highlights
