Does PetroChina have a long-term contract with Russia?

"PetroChina has maintained sound partnership with many gas and crude producers. We have many ongoing long-term contracts, and the executions are generally stable currently, " Dai said. PetroChina is China's leading Russian crude importer via pipeline on the back of its parent company CNPC's term contract with Rosneft and Transneft.

What is PetroChina's domestic crude and gas reserve replacement ratio?

According to latest data,S&P Global Commodity Insights estimates PetroChina imported at least 710,000 b/dof crude from Russia in 2020,accounting for 42% of China's total inflows of 1.68 million b/d from the non-OPEC producer in the year.
