What is the warranty start date of solar modules?

The warranty start date of the Solar Modules stipulated under this Limited Warranty for Solar Modules (hereinafter referred to as "Limited Warranty") is the date of delivery to the Initial Customer or 6 monthsafter the modules are shipped out of the production plant, whichever is earlier (hereinafter referred to "Warranty Start Date").

Do solar panels have a warranty?

The batteries do have limited warrantiesbut as there are no moving parts involved not a lot can go wrong, if there any inherent manufacturing problems with a cell or unit this will most likely come to your attention well inside the warranty period. Inverters are the single most expensive component to replace in your solar panel system.

Are there building regulations for solar panels?

There are building regulations for solar panels, as there are for most home improvements. These government regulations are frequently updated to ensure that any alterations made to properties don't threaten the safety or health of people who live or work in them.

When did solar panels become a building regulation?

In 2005,household electrical work was absorbed into the UK government's official Building Regulations. A year later,the Climate Change and Sustainable Energy Act 2006brought microgeneration systems like solar panels under the umbrella of the Building Regulations.
