

Policies to support the energy storage industry

What are the different types of energy storage policy?

Approximately 16 states have adopted some form of energy storage policy, which broadly fall into the following categories: procurement targets, regulatory adaption, demonstration programs, financial incentives, and consumer protections. Below we give an overview of each of these energy storage policy categories.

What is the impact of energy storage system policy?

Impact of energy storage system policy ESS policies are the reason storage technologies are developing and being utilised at a very high rate. Storage technologies are now moving in parallel with renewable energy technology in terms of development as they support each other.

What are energy storage policy tools?

In general, policies are designed to establish boundaries and provide regulatory guidelines. According to the Energy Storage Association (ESA), the policy tools fall under three categories which are value, access and competition.

How many states have energy storage policies?

Around 15 stateshave adopted some form of energy storage policy,including procurement targets,regulatory adaption,demonstration programs,financial incentives,and/or consumer protections. Several states have also required that utility resource plans include energy storage.

What is a storage policy?

All of the states with a storage policy in place have a renewable portfolio standard or a nonbinding renewable energy goal. Regulatory changes can broaden competitive access to storage such as by updating resource planning requirements or permitting storage through rate proceedings.

How do ESS policies promote energy storage?

ESS policies mostly promote energy storage by providing incentives, soft loans, targets and a level playing field. Nevertheless, a relatively small number of countries around the world have implemented the ESS policies.

Chinese storage related policy is relatively small, there is no price mechanism, but the energy storage industry has attracted more and more China government departments of energy and science and technology"s concern and support, application and demonstration of energy storage project subsidies are gradually advancing.

In its draft national electricity plan, released in September 2022, India has included ambitious targets for the development of battery energy storage. In March 2023, the European Commission published a series of recommendations on policy actions to support greater deployment of electricity storage in the European Union.

" The report focuses on a persistent problem facing renewable energy: how to store it. Storing fossil fuels like coal or oil until it's time to use them isn't a problem, but storage systems for solar and wind energy are still being developed that would let them be used long after the sun stops shining or the wind stops blowing, " says Asher Klein for NBC10 Boston on MITEI's " Future of ...

The bidding volume of energy storage systems (including energy storage batteries and battery systems) was 33.8GWh, and the average bid price of two-hour energy storage systems (excluding users) was ¥1.33/Wh, which was 14% lower than the average price level of last year and 25% lower than that of January this year.

On October 11, 2017, China released its first national-level guiding-policy document covering energy storage. The document, "Guiding Opinions on Promoting Energy Storage Technology and Industry Development" (hereafter referred to as "Guiding Opinions") marks a significant milestone, providing a unified framework for subsequent policies and detailing key development tasks.

The need to reduce greenhouse gas emissions has catalysed the rapid growth of renewable energy worldwide. However, the intermittent nature of renewable energy requires the support of energy storage systems (ESS) to provide ancillary services and save excess energy for use at a later time.
