

## Robotswana household energy storage policy

Should Botswana mobilise local capacities for solar rooftops & mini-grids?

The assessment of the opportunities for solar rooftops, mini-grids and SHS would greatly benefit from the mobilisation of local capacities and perhaps the inclusion of women. Botswana should embark on mobilisation, whereby national competencies can be mapped against the needs along the supply chain.

Why is Botswana implementing a rooftop solar programme?

The Government of Botswana is implementing its Rooftop Solar Programme to create an environment in which end-users can generate their own electricity and sell any excess to BPC. The Programme is a suitable alternative mechanism to increase the uptake of solar energy and facilitate private sector participation.

Does Botswana have a guiding instrument for energy development?

Since 1985,Botswana's energy sector developments have been guided by the Botswana Energy Master Plan (BEMP),which was last reviewed in 2002. Since this last review,developments have progressed without any primary guiding instrumentfor almost 15 years now.

Is Botswana self-sufficient in electricity supply?

The NEP acknowledges that Botswana is capable of being self-sufficient in electric power supplyby utilizing the locally available energy resources optimally. Botswana is highly reliant on imports of refined petroleum products to meet the liquid fuels demand since the country does not have any proven crude oil reserves/refineries.

How can we improve energy production in Botswana?

The use of livestock residues (cow-dung) seems to offer the highest practical opportunity for energy production in Botswana, while municipal solid waste(MSW) can also contribute to the improvement of energy generation, especially at the city level.

Does Botswana have a waste management policy?

Botswana is also a signatory of the Basel Conventionwhich deals with the control of transboundary movement of hazardous waste and its disposal. Therefore, this policy recognises the need for proper waste disposal from the energy sector as well as handling of hazardous waste within the sector.

The World Health Organization, in partnership with the Stockholm Environment Institute (SEI), developed a Household Energy Policy Repository ("the Repository") to serve as an online clearinghouse for national, regional and local policies, regulations and legislation affecting household energy use. This National Energy Policy (NEP) is intended to guide the management and development of Botswana's energy sector, especially the penetration of new and renewable energy sources into the country's energy mix in order to attain energy self-sufficiency and increased security of ...

Botswana has received an \$88 million loan from the World Bank for its first utility-scale battery energy storage system (BESS). The 50 MW/200 MWh project will allow for the stable integration and management of renewable energy on the nation's grid.

The Energy Storage Obligation (ESO) specifies that the percentage of total energy consumed from solar and/or wind, with or through energy storage should be set at 1% in the 2023-2024 timeframe and gradually rise to 4% by 2029-2030, as in the table below.

In last year's edition, SunWiz totted up an estimate of 333MWh of installations during 2021, as reported by Energy-Storage.news at the time. The average residential storage battery system capacity is 12.5kWh, and in most of the country, payback on investment can be achieved in 10 years or less, with payback in eight years in some states.

By 2030, BloombergNEF said, about 61% of all megawatts of energy storage deployed will be primarily used for energy shifting applications, pointing to the growth of co-located solar-plus-storage as an example of a trend which is already taking shape.

According to TrendForce statistics, the projected global installed capacity increment in 2024 is as follows: large-sized energy storage takes the lead with 53GW/130GWh, followed by household energy storage at 10GW/20GWh.
