Do solar panels qualify for a reduced VAT rate?

Under the Government's green incentives, some energy-saving materials and equipment (including solar panels) qualify for a reduced VAT rate. The rate is typically 20% for energy-saving goods and services, but it's currently set to 0% until 31 March 2027. This applies to the supply and installation of solar panels in England, Scotland and Wales.

How much does solar VAT cost in 2024?

In February 2024, this 0% rate was expanded to include standalone storage batteries. The treasury has estimated that reducing the VAT rate on all these products to 0% will cost the government £280 million by 2026/27. Who is eligible for the solar VAT discount?

How does 0% VAT work on solar panels?

If your solar panel materials and installation qualify, the 0% VAT will be automatically applied by your installer. There's no need to fill out an application form or complete any process. Think you might be ready to invest in a solar panel system?

Are solar panels VAT free in the UK?

Since April 2022, UK homes have been able to benefit from zero VAT on solar panel materials and installation. The scheme ends in March 2027 and returns to 5% VAT. While it's at 0%, the average family can save more than £1,000 when choosing to have solar panels installed and up to a further £1,180 a year on energy bills.

What is the solar VAT discount?

The solar VAT discount is part of the government's move in 2022 to change the VAT rate for a host of energy-saving materials to 0% in England, Scotland, and Wales. The full list of qualifying products includes insulation, wind turbines, heating controls, heat pumps, and solar panels.

Do solar panels save tax?

Your tax saving by investing in solar is £22,800.00! As a rough rule of thumb, the tax saving is roughly equivalent to 1 year of benefits of your solar array.
